

**ORDINANCE NUMBER 12 - 59**

**ORDINANCE AMENDING TITLE III: ADMINISTRATION,  
CHAPTER 32: DEPARTMENTS, COMMISSIONS AND OTHER  
ORGANIZATIONS, §32.04, POLICE DEPARTMENT BY AMENDING  
§32.04(G)**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, The East Dundee Code allows for the President, with the advice and consent of the Board of Trustees to appoint part time police officers pursuant to §32.04(G); and

**WHEREAS**, The Illinois Law Enforcement Training & Standards Board (ILETSB) requires that hours for part time officers be restricted during a calendar year; and

**WHEREAS**, The President and the Board of Trustees of the Village of East Dundee have determined that it is in the best interest of the health, safety, morals and welfare of the citizens of East Dundee for Title III, Administration, Chapter 32: Departments, Commissions and Other Organizations, §32.04, Police Department, to be amended.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That, Title III, Administration, Chapter 32: Departments, Commissions and Other Organizations, §32.04(G), Police Department is hereby amended to hereafter read as follows (revisions appear as underlined):

**§32.04 POLICE DEPARTMENT**

(G) Part-time police officers may be appointed by the President with the advice and consent of the Board of Trustees, upon request, for service on the part of the village for such time as may be deemed necessary, and with a restricted number of calendar year hours worked, subject to the following hiring standards:

- (1) Must be a minimum of 21 years of age;

(2) Must possess a valid high school diploma or G.E.D., preferably supplemented by some additional college level course work in a police related field;

(3) Must successfully complete a certified Illinois Law Enforcement Training Standards Board 40-hour firearms training course prior to being authorized to carry a firearm;

(4) Must successfully complete a certified Illinois Law Enforcement Training Standards Board basic part-time 400-hour training program, as provided by law, within 18 months of employment or show proof of prior program completion so a waiver can be requested from the Illinois Law Enforcement Training Standards Board; and

(5) Must possess a valid Illinois driver's license.

**Section Two. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.

**Section Five. Effective Date.** Passed on the 6 day of August, 2012, according to the following roll call vote.
