**A RESOLUTION APPROVING CONTRACT  
CHANGE ORDER WITH WATER WELL SOLUTIONS TO  
RESTART AND COMPLETE WORK ON THE DRILLING OF THE  
SHALLOW WELL IN THE VILLAGE OF EAST DUNDEE**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the Village of East Dundee has entered into a contract with Water Well Solutions for the drilling of the Shallow Well on December 17, 2007; and

**WHEREAS**, a change order approving Water Well Solutions to restart and complete the drilling of the shallow well with Water Well Solutions in the total amount of \$67,223.89. This change order will allow for all well related work to be expedited to make EPA bypass funding available to the Village. The change order is required to restart and complete the work on the shallow well will be \$67,223.89; and

**WHEREAS**, said change order approving the drilling of the shallow well for the cost of \$67,223.89 has been recommended for approval by the Department of Public Works of the Village of East Dundee; and

**WHEREAS**, the new contract price, will be in addition to the Original Contracted amount with Water Well Solutions.

**WHEREAS**, it is deemed necessary and desirable for the Village of East Dundee to approve the Change Order with Water Well Solutions in the total amount of \$67,223.89.

**NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the Village of East Dundee adopts and approves and the President be and he is hereby authorized and directed to sign and the Village Clerk is directed to attest to the execution of Change order to restart and complete the work on the shallow well submitted by Water Well Solutions. to the contract entered into between the Village of East Dundee and Water Well Solutions dated -----, a copy of which is attached hereto and incorporated herein.

**Section Two. Severability.** If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

**Section Three. Repeal.** If any section, paragraph, clause, or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Resolution.

**Section Four. Publication.** This resolution shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
