

ORDINANCE NUMBER 10 - 17

**ORDINANCE AMENDING TITLE III, ADMINISTRATION,
CHAPTER 32, DEPARTMENTS, COMMISSIONS AND OTHER
ORGANIZATIONS
BY ADDING SUBSECTION 32.07(G)
TO SECTION 32.07, BOARD OF FIRE AND POLICE
COMMISSIONERS**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that **Title III, Administration, Chapter 32, Departments, Commissions and Other Organizations, Section 32.07, Board of Fire and Police Commissioners**, be amended by adding **Subsection 32.07(G)**.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That **Title III, Administration, Chapter 32, Departments, Commissions and Other Organizations**, of the Village of East Dundee Code of Ordinances is hereby amended by adding a **Subsection 32.07(G) to 32.07, Board of Fire and Police Commissioners**, as follows:

' 32.07 BOARD OF FIRE AND POLICE COMMISSIONERS

§32.07(G) Notwithstanding any provision to the contrary, any member of the Board of Fire and Police Commissioners may elect to forego any, or all, of the compensation to which they are otherwise entitled for attendance at meetings of the Board of Fire and Police Commissioners. Any member of the Board of Fire and Police Commissioners desiring to forego compensation shall notify the Village

Treasurer, in writing, of the election to forego all or part of their compensation and shall state the date upon which the election shall take effect and the duration of the election to forego compensation. Nothing in this Section shall be construed to prohibit any commissioner from rescinding the election to forego compensation, upon written notice to the Village Treasurer of their desire to rescind the election to forego compensation.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
