Source Water Information

The Source of Drinking water used by East Dundee is Ground Water. Well #2 - 408 Barrington Ave, Well #3 - 411 1/2 Barrington Ave Well #4 - 16N187 Rt. 25

Source of Drinking Water: The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.

Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Source Water Assessment

To determine East Dundee's susceptibility to groundwater contamination, the Well Site Survey, published in 1992, and the survey conducted under the pilot source water protection program were reviewed. During the surveys of East Dundee's source water protection area, potential sources, routes, or possible problem sites within the minimum setback zones, maximum setback zones, and recharge area were recorded. There are no sites within the minimum setback zones. Within the maximum setback zones, thirteen sites are located within the zone around wells #2 and #3 and two sites are located within the zone around well #4. There are eight sites located within the recharge area. Twenty additional sites are located outside the setback zones and recharge area. The Illinois EPA considers the source water of this facility to be susceptible to contamination. This determination is based on a number of criteria including: monitoring conducted at the wells, monitoring conducted at the entry point to the distribution system, the available hydro geologic data on the wells, and the land-use activities in the recharge area of the wells.

Consumer Confidence Report

Lead and Copper Definitions:

If Present elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village of East Dundee is responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Action Level Goal (ALG): The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Water Quality Test Results Definitions:

The following tables contain scientific terms and measures, some of which may require explanation.

Maximum Contaminant Level or MCL: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology

Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

ppm - mg/l: milligrams per liter or parts per million - or one ounce in 7,350 gallons of water.

ppb - ug/l: micrograms per liter or parts per billion - or one ounce in 7,350,000 gallons of water.

n/a: not applicable.

Avg: Regulatory compliance with some MCLs are based on running annual average of monthly samples.

pCi/L: Picocuries per liter (a measurement of radioactivity)

Maximum residual disinfectant level or MRDL: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants

Maximum residual disinfectant level goal or MRDLG: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Other Info— Change in Water Quality Coming Soon!

The Village of East Dundee is in the last stage of construction of the new water treatment facility. This new facility is scheduled to come on line in the Summer of 2012. Once the new facility is up and running the water quality through out the village will change. The water will be softened from current levels of 444 mg/l of hardness to a level near 125 mg/l. It is suggested that during the first month of operation you shut your home softener off. During the first thirty days of new water operations the department will be aggressively flushing the system; this is to help with a uniform water quality through out the system. After thirty days it's up to personal preferences if you restart your home treatment. If you decide to restart your home treatment units please contact the water department to obtain the new quality levels. You will need to adjust your home units to the new levels. If you run the unit at old settings you may over soften your water and this could cause long term plumbing problems. Some contaminants are sampled less frequently than once a year; as a result, not all contaminants were sampled for during the CCR calendar year. If any of these contaminants were detected the last time they were sampled for, they are included in the table along with the date that the detection occurred. There is not a MCL for sodium, Monitoring is required to provide information to consumers and health officials that are concerned about sodium intake due to dietary precautions.
