**5.1 Liquor License Expansion Request & Presentation – Paintball Explosion**

Police Chief Mee introduced Romeo Kapudija and TJ Andres from Paintball Explosion who are looking for an expansion of their current Class D liquor license. They are interested in hosting various events at the Polar Dome where liquor would be sold and consumed throughout the Dome. Mr. Kapudija said that he has been approached by various promoters to host live music events at the Polar Dome. Currently their license does not allow for the sale of liquor throughout the entire premises and he would like to set up various distribution areas within the Polar Dome as well as the grandstand area. He said that the main floor would be standing room only and only beer would be sold at these events. Police Chief Mee said the grandstand holds a maximum occupancy of 500 people. If an event would host more than 500 people, the Fire Department would need to conduct a study beforehand. Mr. Andres said eventually they would like to host outdoor events but currently do not have the space to do so. He said the indoor events will have a designated fenced area with only one point of entry to allow for ages twenty one and older. Mr. Kapudija said the music venues will be hosted during the winter months when the Azoosment Park is closed for the season. Mr. Andres said that during the summer, their music events would be held only after Azoosment Park's hours of operation have ended for the day. This would also allow for ample parking to be available for the events. He said that they would like to host these events starting in December and that he has received approval by property owner Sterling Bay to do so. Police Chief Mee said that a Class H liquor license is the closest license to meet the request and that he will meet with Mr. Kapudija and Mr. Andres again to sort through the details. He will also meet with the Village Administrator and Attorney to create a text amendment that would accommodate the request. The item would then go before the Village Board for approval. Village Administrator Bob Skurla said that if outdoor events occur, he will recommend to the Village Board that a sound engineer do an assessment to ensure that the noise level will not be a nuisance to neighboring residents.
