CALL TO ORDER

President Bartels calls to order the Regular Village of East Dundee Regular Board Meeting at 6:00 pm.

ROLL CALL:

Trustees Ruffulo, Gorman, Lynam, Miller, VanOstenbridge, Skillicorn and President Bartels.

Motion to allow Trustee Ruffulo to attend the meeting via conference phone by Miller/VanOstenbridge. Roll: Ayes -6 – Trustees Gorman, Lynam, Miller, VanOstenbridge, Skillicorn and President Bartels. Nays -0. Absent -0. Motion carries.

Also in attendance Village Administrator Bob Skurla, Village Engineer Joe Heinz, Public Works Director Jim Kelly, Chief of Police Terry Mee, Assistant Village Administrator Heather Maieritsch and Village Clerk Jennifer Rehberg.

PLEDGE OF ALLEGIANCE: Recited

Motion to move the swearing in new police officer Vincent P. Lara to the first item on the agenda by VanOstenbridge/Lynam.

Roll: Ayes -7 – Trustees Ruffulo, Gorman, Lynam, Miller, VanOstenbridge, Skillicorn and President Bartels. Nays -0. Absent -0. Motion carries.

Swearing in Police Officer Vincent P. Lara

Chief Mee introduced Officer Lara and Village Clerk Rehberg swore him in.

PUBLIC PARTICIPATION:

Terri Holt - Pond Gate Farm Resident

Ms. Holt opposes the IAA site plan and worried about their water.

Brian Dunlop - Pond Gate Farm Resident

Mr. Dunlop also opposes the IAA site plan and would like more research on the water since they all have well water. He asks that the village postpone the vote.

Robert Kosin - Village of Barrington Hills

Mr. Kosin is acknowledging the exchange of information from Barrington Hills to East Dundee. He passed on engineering information to the staff in relevance to the grading plan and surface detention. Barrington Hills would like to work with East Dundee on this issue.

OLD BUSINESS:

<u>Discussion:</u> Gorman stated he went and viewed the site. He put some information together and shared with the Board his fact finding of the site. He went through each claim and the facts he researched. Bartels states these are Gorman's facts, not official. His concern is that other Village residents oppose this vacation and the Village will be sued if the vacation is approved. Gorman thinks there should be an

alternative. He suggests we table and offer a license agreement to the O'Leary's and re-look after the civil case.

Roll: Ayes -2 – Trustees Ruffulo and Lynam. Nays – 5 – Trustees Gorman, Miller, VanOstenbridge, Skillicorn and President Bartels. Motion fails.

2. Motion to Approve the IAA Site Plan

Michael J. Madden, VP Real Estate & Development, Insurance Auto Auctions addressed the Board and gave a background on the company. Mr. Madden introduced staff and representatives from IAA. The NYSE symbol is KAR. He explained the different branches of their company and how the business runs. They capture totaled vehicles and sell them through the internet and live auctions. They do not fix or sell the parts. They are insured by ACE. The site they are looking at is zoned for their business. They will do the following 1) construct a 10 ft berm and 2) install a test wall and will do testing once a year and submit the tests to the Village of East Dundee. Bartels asked what happens if fluid leaks out of a vehicle. Madden explained it is gathered and disposed of through EPA standards. Bartels asked how many vehicles are in the plant at a time. They are moving from Wheeling. They can put 155 cars per acre. Phase 1 will be 15 acres of recycled asphalt. Scott Wilson, Engineer, explained the surface drainage process. All the water will eventually drain to W. Commonwealth Drive's storm sewers. Michael V. Machalinski, explained the site's existing conditions. Bartels asked Heinz if it meets village code. Skurla asked what would happen if fluids would get into the soil. Tom Hahne explained the ground water system. They houses wells are approximately 220 feet deep. The water runs towards the river, to the south west. He feels the fluids would stay on the surface water system, not the deep water system. Heinz stated it will have a storm water lift station. They are a low-risk operator in Tom Hahne. The test well will be 200-220 feet deep once a year. Hahne explained what the steps would be if they find contamination. Mary Ann Mullin, attorney at SchiffHardin, explained her experience with IAA and how they would take care of a contamination. Gorman asked if there is any litigation currently with this issue. She explained the Seattle case. Miller asked who cleans up the mess if there is contamination. Mullin stated if IAA does not clean it up, IEPA would oversee the cleanup. Skillicorn asked if we can receive test results.

Trustee Ruffulo left the meeting at 7:02 pm.

Gorman asked if the collection at the detention area be tested on a regular basis. Wilson explained there will be visual checking. Wilson mentioned there are asphalt facilities to the west. Skillicorn asked if we can modify the site plan and if we can see the test data. Skurla stated yes.

Motion to Approve IAA Site Plan contingent to the test well by Miller/Lynam Roll: Ayes -6 – Trustees Gorman, Lynam, Miller, VanOstenbridge, Skillicorn and President Bartels. Nays -0. Absent -1 – Trustee Ruffulo. Motion carries.

Discussion: Heather Maieritsch put together the summary spread sheet for the bids. The staff recommendation was to go with Flood Brothers. Every resident will get 2 cans (65 gallons – regular and recycle). Flood has unlimited pickup, still on Wednesdays. They will also supply an electronics recycling bin. They will also have chemical disposal options. Gorman asked Skurla to do due diligence on the company and he reported no problems. Skillicorn would like to see the revenue from GAT to cover the cost of waste pick up so there would be no charge to the residents.
