Chief Mee stated that there was discussion of the event at the last Committee of the Whole Meeting. Mr. Recalde was in attendance representing the event for August 27, 3:00 p.m. - 11:00 p.m. Also in attendance were representatives from Los Cocos who will be requesting the liquor license. The event is also on the Village Board Meeting agenda, tonight. Mee stated that two Police Officers will be assigned to the event to provide crowd control and order maintenance. The event includes bull riding, six (6) bands, beer service, and food. Mr. Recalde addressed the Commission and explained the logistics of the event. They will close off the area except through the main entrance. They will check IDs and issue two different bracelets for minors and adults. There will be 11 private security guards to monitor the event and the liquor service area. Bartels concern is controlling the limit of alcoholic beverages a person can purchase. The bracelets will be tamperproof. Each of two bleacher areas in the beer service enclosure will hold 400 people. Mr. Recalde stated this is a family event and they want it to become annual event. The fencing will be "riot-stopper" fencing. The bull riding organizer has its own cages for the bulls and the bull riding area. The food will be family-oriented. Bartels stated this is something new, and he wants everything to be safe. Mee feels comfortable with this with the two Police Officers in attendance. Miller asked how many entrances there will be in the liquor area. Mr. Recalde stated, one.
