

I. CALL TO ORDER:

Chairman Nelson called the meeting to order at 7:18 pm.

II. ROLL CALL:

Present were Chairman Christopher Nelson and Commissioner Andy Yuscka.

Also present was Village Manager Joseph Cavallaro.

III. APPROVAL OF MINUTES:

A. Approval of Minutes: May 3, 2021

MOTION: Moved by Commissioner Yuscka and seconded by Chairman Nelson to approve the Minutes of May 3, 2021. Upon roll call, motion was approved.

IV. ITEMS FOR DISCUSSION:

A. Recommendation to Approve Ordinance Establishing Class N “To Go” Liquor Classification

Manager Cavallaro said several of the Village’s liquor license holders have indicated that they would like to continue to allow for pre-packaged sales for off premise consumption.

He said the new license classification Class N was crafted specifically to allow for “To Go” privileges. A Class N license would be made available as an add-on to specific existing license classifications for on premises consumption, similar to the Class E outdoor dining classification.

Manager Cavallaro said there is an additional \$150 fee for a Class N license.

MOTION: Moved by Commissioner Yuscka and seconded by Chairman Nelson to recommend the adoption of an Ordinance amending the Alcoholic Liquor Regulations of the West Dundee Municipal Code to add a Class N “To Go” liquor classification with an annual fee amount of \$150. Upon roll call, motion was approved.

Manager Cavallaro said the annual liquor license renewal applications received for the amended license period of June 1, 2021 through April 30, 2022 have been thoroughly reviewed and are ready for approval.

MOTION: Move to approve the renewal of a **Class AA** Liquor License for RocHaus, subject to satisfaction of any outstanding license requirements.

MOTION: Move to approve the renewal of a **Class AAA** Liquor License for Bikini Bottom, subject to satisfaction of any outstanding license requirements.

MOTION: Move to approve the renewal of **Class B** Liquor Licenses for Dominick's Pizzeria, subject to satisfaction of any outstanding license requirements.

MOTION: Move to approve the renewal of **Class C** Liquor Licenses for Osco Drug, Route 31 Pantry & Liquors, and Walgreens, subject to satisfaction of any outstanding license requirements.

MOTION: Move to approve the renewal of a **Class CC** Liquor License for Sonesta Select subject to satisfaction of any outstanding license requirements.

MOTION: Move to approve the renewal of **Class CCC** Liquor Licenses for Casey's, Johns Mobile, Speedway and Thornton's, subject to satisfaction of any outstanding license requirements.

MOTION: Move to approve the renewal of a **Class D** Liquor License for VFW Post 2298, subject to satisfaction of any outstanding license requirements.

**C. Consideration of Video Gaming Establishment License Renewal Applications
June 1, 2021 – April 30, 2022 License Year**

Manager Cavallaro said the Board passed an Ordinance on March 1, 2021 to establish separate Video Gaming Licenses for Terminal Operators and Establishments and to define the fees for each type of license.

Manager Cavallaro said these changes resulted in some confusion among the licenses, and authorization of an extension of all existing Liquor and Gaming Licenses from April 30, 2021 until May 31, 2021.

MOTION: Moved by Commissioner Yuscka and seconded by Chairman Nelson to approve the renewal of Video Gaming Establishment Licenses as submitted for Bamboozels, Bikini Bottom Bar & Grill, Blue Line Bar & Grill, The Chubby Bullfrog Bar & Grill, Chunky Dog Bar & Grill, Dominick's Pizzeria, Tri-City Evergreen Post 2298 and the Village Squire for the period June 1, 2021 through April 30, 2022, subject to submittal of any outstanding items. Upon roll call, motion was approved.

**D. Consideration of Video Gaming Terminal Operator License Applications
June 1, 2021 – April 30, 2022**

Manager Cavallaro reiterated that there are separate Video Gaming Licenses for Terminal Operators and Establishments.

MOTION: Moved by Commissioner Yuscka and seconded by Chairman Nelson to approve the renewal of Video Gaming Terminal Operator Licenses as submitted by Gaming and Entertainment Management for Bamboozels and The Chubby Bullfrog Bar & Grill; Gold Rush Amusements, Inc. for Bikini Bottom Bar & Grill; JJ Ventures Gaming, LLC for Blue Line Bar & Grill; Illinois Gaming Investors LLC for Chunky Dog Bar & Grill and ACCEL Entertainment Gaming, LLC for Dominick's Pizzeria, The Village Squire and VFW Post 2298, for the period of June 1, 2021 through April 30, 2022, subject to submittal of any outstanding items. Upon roll call, motion was approved.
