

**LOCAL LIQUOR CONTROL COMMISSION**

**I. CALL TO ORDER:**

Chairman Nelson called the meeting to order at 7:21 pm.

**II. ROLL CALL:**

Present were Chairman Christopher Nelson and Commissioners Pat Hanley and Andy Yuscka. Also present were Village Manager Joseph Cavallaro and Attorney Jim Binninger.

**III. APPROVAL OF MINUTES:**

**A. February 18, 2019**

**MOTION:** Moved by Commissioner Yuscka and seconded by Commissioner Hanley to approve the minutes of February 12, 2019 as presented. Motion was approved by voice vote.

**IV. ITEMS FOR DISCUSSION:**

**A. Class A & E Liquor License Request**  
**Jimmy's Chicken & Ribs, 551 S. 8<sup>th</sup> Street**

Manager Cavallaro said this is a change in ownership from Kabob Kitchen to Jimmy's Chicken & Ribs. A thorough review of the application has been done by the West Dundee Police Department and a recommendation for approval has been provided.

**MOTION:** Moved by Commissioner Hanley and seconded by Commissioner Yuscka to adopt the Finding of Fact and issue Class A and Class E liquor licenses to Jimmy's Chicken & Ribs, Inc. for the establishment located at 551 S. 8<sup>th</sup> Street, pursuant to the conditions noted. Upon roll call, motion was approved.

**B. Video Gaming License Request**  
**Jimmy's Chicken & Ribs, 551 S. 8<sup>th</sup> Street**

Manager Cavallaro said that as part of their remodel construction a new partition wall near the front entrance of the restaurant is planned for the location of the gaming machines. There is also an increase in the number of video gaming machines from 3 to 5.

**MOTION:** Moved by Commissioner Yuscka and seconded by Commissioner Hanley to adopt the Finding of Fact as presented and approve the issuance of a video gaming license to Jimmy's Chicken & Ribs, Inc. for five (5) video gaming devices to be located within the establishment known as Jimmy's Chicken & Ribs, located at 551 S. 8<sup>th</sup> Street. Upon roll call, motion was approved.

**C. Liquor License Renewal Applications  
May 1, 2019-April 30, 2020 License Year**

Manager Cavallaro said all applications have been submitted in their complete form, with a few minor deficiencies, mainly housekeeping issues.

Manager Cavallaro said that a request for amended hours has been received from Randall Oaks Golf Club for the operation for Class G licenses to begin at 7:00 am instead of 8:00 am. He added if approved, an ordinance will be presented for recommendation to the Village Board at their May meeting.
