**I. CALL TO ORDER:**

Chairman Nelson called the meeting to order at 6:50 pm.

**II. ROLL CALL:**

Present were Chairman Nelson and Commissioner Yuscka. Commissioner Hanley had an excused absence. Also present was Village Manager Cavallaro.

**III. APPROVAL OF MINUTES:**

**A. June 1, 2015**

**MOTION:** Moved by Chairman Nelson and seconded by Commissioner Yuscka to approve the Local Liquor Control Commission Minutes of June 1, 2015. The motion was approved by unanimous voice vote.

**IV. ITEMS FOR DISCUSSION:**

**A. Class A Liquor License Application**  
**Dooley's Irish Ale House**  
**98 W. Main Street**

Manager Cavallaro said that a Class A Liquor License has been requested for Dooley's Irish Ale House, to be located at 98 W. Main Street (formerly MT Barrel's).

Matthew Harrison, one of the owners, said that Dooley's will be a family friendly business serving Irish food with an American twist and middle ground pricing. He is hiring an executive chef and will be operating the business on the first two floors with the third floor reserved for parties.

Chairman Nelson asked Mr. Harrison about his previous experience and what changes he will be making to the exterior of the building. He said he has worked in a restaurant and has operated his own business for ten (10 years) and will be making changes to the signage, paint and will be taking the awning down.

Chairman Nelson asked him if he plans to interact with the theater. Mr. Harrison said he has been in talks with Mr. Krak about providing food and mixology drinks. He believes the theater will be open Thursdays, Fridays and Saturdays.

Commissioner Yuscka asked if he will be brewing craft beers. Mr. Harrison said he will not be brewing beer, but will be serving craft beers.

**MOTION:** Moved by Commissioner Yuscka and seconded by Chairman Nelson to adopt the Finding of Fact as presented and recommend issuance of a Class A liquor license for Dooley's Irish Ale House located at 98 W. Main Street, pursuant to the conditions noted. Upon roll call, motion was approved.
