**I. CALL TO ORDER:**

Commissioner Yuscka called the meeting to order at 7:20 pm.

**II. ROLL CALL:**

Present were Commissioners Yuscka and Hanley. Chairman Nelson arrived at 7:27 pm. He was at a scheduled speaking engagement.

Also present were Village Manager Joseph Cavallaro, Attorney John Brechin and Police Chief Andrew Wieteska.

**III. APPROVAL OF MINUTES:**

**A. September 26, 2016**

**MOTION:** Moved by Commissioner Hanley and seconded by Commissioner Yuscka to approve the Minutes of the September 26, 2016 Local Liquor Control Commission Meeting. Motion was approved unanimously by voice vote.

**IV. ITEMS FOR DISCUSSION:**

**A. Daily Liquor Permit Requests-St. Catherine of Siena  
Paint & Sip, December 16, 2016  
Trivia Night, February 3, 2017**

Commissioner Yuscka said that St. Catherine's began hosting these two events in 2015 and both are fund raising events organized by St. Catherine of Siena School. Both events will be held in the school gymnasium beginning at 6 pm and ending no later than 11:30 pm.

Commissioner Yuscka said that St. Catherine's typically holds multiple special events per year involving liquor privileges and has a very positive history within the community.

**MOTION:** Moved by Commissioner Hanley and seconded by Commissioner Yuscka to approve a Daily Liquor Permit for St. Catherine of Siena, located at 845 W. Main, for the Paint & Sip on December 16, 2016 from 6-11:30 pm and Trivia Night on February 3, 2017 from 6-11:30 pm. Upon roll call, motion was approved.

**B. Daily Liquor Permit Request – Dundee Sports Bar  
LifeZone 360 Halloween Event, October 29, 2016**

Kyle Walter from LifeZone 360 presented his request for a Special Event Application and Daily Liquor Permit request for the Cars and Chaos Halloween Car Show and Food Truck Festival in the parking lot of LifeZone 360 on the 29<sup>th</sup> of October.

He said they are expecting 250 cars and 6 food trucks. He said the liquor will be sold from a trailer with a separate "over 21" wristband and ID's would be checked. He said there will be activities for kids including a bounce house and face painting. Portapotties will also be on sight.

He said there are 100 confirmed entries for the car show as of this date, but the goal is for 250 cars.

**MOTION:** Moved by Commissioner Hanley and seconded by Commissioner Yuscka to approve a Daily Liquor Permit for Dundee Sports Bar for Cars and Chaos Halloween Car Show and Food Truck Festival to take place at 999 W. Main Street on October 29, 2016 from 11:00 am to 6:00 pm. Upon roll call, motion was approved.

**C. Class C Liquor License – Dundee Supermart (new owner)  
200 Washington Street**

Manager Cavallaro said that Dundee Supermart is changing ownership and Mr. Viraj Patel will be the sole owner of Dundee Supermart and has applied for a Class C Liquor License.

Police Chief Wieteska said that there has been a favorable background check and that the owner/agent has been fingerprinted by the Village of West Dundee Police Department.

**MOTION:** Moved by Commissioner Hanley and seconded by Commissioner Yuscka to adopt the Finding of Fact and issue a Class C liquor license for Dundee Supermart located at 200 Washington Street pursuant to the conditions noted. Upon roll call, motion was approved.
