B. ARC2016-06-825 Village Quarter Road-Consideration Building Elevation Color Change for Village Quarter Commercial Condos

Mr. Sasha Chadwick, property manager for the condos at 825 Village Quarter Road addressed the Commission regarding the color changes for Buildings A, B and C. He presented the new color palette, which is earth toned. He said that in addition to refreshing the exteriors by way of these proposed color changes, maintenance related replacement of trim will be done as necessary. He also said the medium-density fiber-board will be replaced with a much more durable material of fiber –cement.

Discussion ensued regarding the color choices, the amount of fiber-board that will be replaced, the amount of trim, suggested removal of some of the trim and the selection of colors for the areas above the dormers and doors.

A. ARC2016-05-1100 Wesemann Drive-Consideration of Site, Building, Signage, Landscaping and Lighting Design for Oelheld (Oakview Corporate Park)

Ms. Kersten Leahy, Associate Project Manager of Opus, representing Oelheld, is seeking approval for a new light industrial facility at 1100 Wesemann Drive in the Oakview Corporate Park.

Ms. Leahy said the building is approximately 23,000 square feet with 7,500 square feet to be used for office space. She explained that the building's exterior consists of structural precast walls with a steel interior structure. She said the precast will be painted to match the company's corporate colors of light and dark gray along with an accent of red to reinforce corporate identity and enhance the building's appearance.

A brief discussion was held regarding the location of the utilities and refuse area.
