Attached please find an application for a video gaming license request for a Bikini Bottom Bar & Grill, Inc. (dba Bikini Bottom Bar & Grill), located at 105-107 W. Main Street.

The gaming license application has been filled out and received. Bikini Bottom is proposing to utilize the services of VIC Entertainment, LLC as their terminal operator. Attached is a copy of their application and submittal documentation.

Below please find a Finding of Fact which should be adopted by the Local Liquor Control Commission if the Commission deems the license appropriate, with a recommendation for approval to the Village Board.


It is recommended that the Local Liquor Control Commission make the following Finding of Fact pursuant to this application:

1. That Bikini Bottom Bar and Grill, Inc. currently holds a Class A liquor license at 107 W Main and has requested a video gaming license for 4 machines.
2. The application was properly completed and a \$35 license fee and \$135 per device amusement device fee has been submitted and deposited.
3. That the Village staff and Police Department have reviewed the application and found it in order in compliance with the Village video gaming regulations.
4. That there are no pending liquor violations or excessive police contacts regarding the establishment, and all documentation related to the existing liquor license is current and in order.
5. That the Village has received copies of the documentation from the Illinois Gaming Board for license issuance at the above location, as well as documentation that VIC Entertainment, LLC is an approved terminal operator within the State of Illinois.
6. That a copy of an exhibit illustrating the designation of the restricted gaming area has been provided.

It is recommended that the above Finding of Fact be adopted for the issuance of a video gaming license to Bikini Bottom Bar and Grill, Inc. for this establishment at 105-107 W. Main Street for 4 machines.

Upon adoption, it is recommended that the Finding of Fact be forwarded on to the Village Board for final approval.


