1. Meeting called to order by Chairman Mack at 7:05 p.m.

2. Roll call:

Present: Chairman Mack, Commissioner Rynders, Commissioner Rohlwing
Also present: Police Chief Gorski, Fire Chief Harris

3. Approval of the Agenda:

Motion by Commissioner Rohlwing to approve the agenda. Second by Commissioner Rynders. All voted in favor. Motion passed 3-0.

4. Approval of Minutes:

Motion by Chairman Mack to approve the minutes of the March 11, 2021 Regular Meeting. Second by Commissioner Rohlwing. All voted in favor. Motion passed 3-0.

7. Old Business

A. Police Officer lateral transfer testing process

- i. Chief Gorski reported that he has received two applications thus far for lateral transfer. He will review them and provide an update at a future meeting.

B. Police Officer Entry Level Testing (current list expires 07-03-21)

- i. A total of 39 applicants signed up for the examination through Standard & Associates.
- ii. A total of 31 applicants challenged the written examination administered by Stanard & Associates. All passed.
- iii. An email will be sent to all applicants who passed the written examination notifying them of the process to apply for preference points. The deadline to apply for preference points will be 4:00 p.m. on June 21, 2021.
- iv. On or about June 22, 2021 the Initial Eligibility List will be established. The top 20 candidates as listed on the Initial Eligibility List and all applicants who possess a certificate attesting to

his/her successful completion of the Minimum Standards Basic Law Enforcement Training Course will be invited to participate in the oral interview process.

- v. Tentative available dates for the oral interviews are July 12, 13, 14, 19 and 20. Supervisor of Administrative Services Kevin Burke will again assist the Commission in scheduling oral interviews.
- vi. It is anticipated the Final Eligibility Register will be ready to post on or about July 20, 2021.

8. New Business

A. Update on Probationary Firefighter (Mabry – hired 06-08-20)


- i. Chief Harris reported that FF/PM Brian Mabry continues to perform in an acceptable manner. There were no concerns to bring forward to the Commission thus FF/PM Mabry successfully completed his probationary period effective 06-08-21. Congratulations Brian!

10. Adjournment


