1. Meeting called to order by Commissioner Rohlwing at 7:05 p.m.

2. Roll call:

3. Approval of the Agenda:

Motion by Commissioner Rohlwing to approve the agenda. Second by Commissioner Rynders. All voted in favor. Motion passed 2-0.

4. Approval of Minutes:

Motion by Commissioner Rohlwing to approve the minutes of the December 9, 2020 Regular Meeting. Second by Commissioner Rynders. All voted in favor. Motion passed 2-0.

7. Old Business

A. Police Officer lateral transfer testing process

- i. Commissioner Rynders provided for review proposed language for police officer lateral transfer testing process.
 - a. Attorney John Kelly and Village Manager Cavallaro reviewed the proposed language. Both approved of the language as written.
 - b. The proposed language, if approved by the Village Board, will amend Section 2-3C-4: Eligible Registers and Appointments of the Village of West Dundee Municipal Code to include “Section C. Police Officer – Accelerated Entry/Lateral Transfer”.
 - c. Commissioners discussed if applicants could be on both eligibility lists. It is preferred that applicants are only allowed to be on one eligibility list – either the lateral transfer list or the entry-level list. This language will be included in the final draft before approval by the Village Board.
 - d. Chief Gorski reported this item has been included on the agenda of the March 15, 2021 Village of West Dundee Board Meeting.

Motion by Commissioner Rohlwing to approve the proposed language amending Section 2-3C-4: Eligible Registers and Appointment of the Village of West Dundee Municipal Code to include “Section C. Police Officer – Accelerated Entry/Lateral Transfer”. Second by Commissioner Rynders. All voted in favor. Motion passed 2-0.

- B. Police Officer Entry Level Testing (current list expires 07-03-21)
 - i. Chief Gorski has contacted Stanard to schedule dates for applications and the testing process.
 - ii. Written exam will be administered using an on-line format.
 - iii. Commissioner Rynders will work with Chief Gorski on the process specifics.


- A. Update on Probationary Firefighter (Mabry – hired 06-08-20)

10. Adjournment


