I. CALL TO ORDER:

III. APPROVAL OF MINUTES:

MOTION: Moved by Commissioner Yuscka and seconded by Commissioner Osth to accept the terms of the plea agreement set forth, to direct Mr. Tousey to prepare an appropriate order which incorporates the stated provisions for Chairman Keller's signature and to authorize Interim Chief Wieteska to have appropriate discussions with local management to ensure they are fully aware of the facts and circumstances of the violation to avoid future violations.
