

**ORDINANCE No. 2019-18**

**AN ORDINANCE CHANGING THE NAME OF THE ROAD KNOWN AS  
ILLINOIS STATE ROUTE 72 AND/OR HIGGINS ROAD  
TO WEST MAIN STREET IN THE VILLAGE OF WEST DUNDEE**

WHEREAS, Illinois State Route 72, also commonly known as Higgins Road, is one of the main thoroughfares in the Village, abutted by many businesses and residences; and

WHEREAS, the Village has previously designated said roadway as "Main Street"; and

WHEREAS, addresses of properties along this thoroughfare are referred to by all of these names, causing some confusion in the Village; and

WHEREAS, this roadway is known as Main Street in the neighboring municipality to the west; and

WHEREAS, in order to avoid confusion and to provide consistency in the name of this roadway, the corporate authorities have determined that it is advisable to change its name to "West Main Street" for that portion of the roadway lying within the borders of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WEST DUNDEE, KANE COUNTY, AS FOLLOWS:

Section 1. That portion of Illinois State Route 72 and/or Higgins Road running within the borders of the Village shall hereafter be designated, named and known as "West Main Street."

Section 2. The Village Clerk is hereby directed to forward, by certified or registered mail, a certified copy of this Ordinance to the local United States Post Office, and the Kane County Clerk / Elections Department, without delay.

Section 3. Any and all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict superseded and waived.


Section 4. If any section, subdivision, sentence or phrase of this ordinance is for any reason held to be void, invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.


Section 5. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law, provided, in no event shall this Ordinance take effect sooner than thirty (30) days after the election authorities having jurisdiction in the area, and the post office branch serving the area, have been notified by the corporate authorities of the change of name described in this Ordinance, by certified or registered mail, in accord with the requirements of the Illinois Municipal Code, 65 ILCS 5/11-80-19.
