

**ORDINANCE 2017-03**

***An Ordinance Amending Title 7, Motor Vehicles and Traffic  
Chapter 2, Parking, Stopping, or Standing on Roadway  
of the West Dundee municipal Code  
so as to add 7-2-10: Overnight Parking Permits Public Parking Lots***

WHEREAS, the Village of West Dundee, Kane County, Illinois, is a home rule municipality as contemplated under article VII, Section 6, of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS:

Section 1: The foregoing recitals are hereby incorporated in this Section One as if said recitals were fully set forth herein.

Section 2: Title 7, Motor Vehicles and Traffic, Chapter 2-8 is hereby amended to add Section 7-2-10 to the West Dundee Municipal Code:

**7-2-10 Overnight Parking Permits Public Parking Lots**

1. No overnight parking shall be permitted in Public Parking Lots without a Village issued overnight parking permit.
2. Permits will only be issued to vehicles registered to a property adjacent to the public lot. Appeals and special permit requests can be directed to the Police Chief, Village Manager, and Village Board (or their designees) and issued at their discretion, when warranted.
3. The cost for an overnight parking permit shall be \$20.00. Overnight parking permits are valid for a one (1) year period which shall run May 1<sup>st</sup> through April 30<sup>th</sup>.
4. Overnight parking permits shall be placed in the rear window on the driver's side of your vehicle.
5. Winter parking parameters during and following a snow event:
  - a. South Lot: Parking will only be allowed on the East side of the lot.
  - b. North Lot: Parking will only be allowed adjacent to the dumpster enclosure East of Emmett's and behind the Village Squire.
6. Overnight parking permits may be rescinded for a violation of any of the regulations outlined in this section.


Section 3: Any policy, resolution or ordinance of city, or any part thereof, that conflict with the provisions of this ordinance shall be and is hereby repealed to the extent of such conflict.


Section 4: The ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
