

ORDINANCE 2017-07

**AN ORDINANCE AMENDING THE VILLAGE OF WEST DUNDEE
ANNUAL BUDGET FOR FISCAL YEAR 2016-17**

WHEREAS, the Village of West Dundee, Kane County, Illinois, is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Village of West Dundee, Kane County, Illinois, has adopted 65 ILCS 5/8-2-9.1 and 8-2-9.2 through 8-2-9.10 in lieu of passing an appropriation ordinance prior to the end of the first quarter of the fiscal year; and

WHEREAS, 65ILCS 5/8-2-9.4 requires that the annual budget shall be adopted by the corporate authorities before the beginning of the fiscal year to which it applies; and

WHEREAS, Ordinance 96-18 requires the preparation of an annual budget ordinance for approval by the Board of Trustees, and

WHEREAS, The Village Board of the Village of West Dundee adopted Ordinance No. 2016-16 on April 18, 2016, and

WHEREAS, due to unforeseen revenue and expenditure changes for the 2016-17 fiscal year, it is desirous to amend the annual budget for the period commencing May 01, 2016 and ending April 30, 2017.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS, as follows:

Section 1: That the Village of West Dundee Annual Budget For Fiscal Year 2016-17 be amended as follows:

1-00-9-0200	From \$600,000 to \$660,000
1-00-9-0300	From \$0 to \$84,000
4-00-3-0100	From \$600,000 to \$660,000
4-20-5-9000	From \$0 to \$270,000
4-42-5-1000	From \$270,000 to \$24,000
4-42-5-1110	From \$0 to \$43,500
4-42-5-1200	From \$0 to \$60,000
4-42-5-1310	From \$30,400 to \$160,400
5-00-3-1500	From \$0 to \$84,000
5-00-3-2000	From \$0 to \$270,000
5-00-3-3900	From \$500,000 to \$900,000

Section 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgement shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

Section 3: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

Section 4: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.
