

ORDINANCE 2016-10

AN ORDINANCE AMENDING TITLE 1, CHAPTER 7, ARTICLE A, SECTION 1-7A-8, INTEREST IN CONTRACT OR TRANSACTION, OF THE MUNICIPAL CODE OF THE VILLAGE OF WEST DUNDEE, ILLINOIS

WHEREAS, the Village of West Dundee, Kane County, Illinois is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Illinois Compiled Statutes, Chapter 50 ILCS 105/3, establishes guidelines to prevent any prohibited interest in a government contract by elected and appointed officials in Illinois; and

WHEREAS, the Illinois Compiled Statutes, Chapter 65 ILCS 5/3.1-55-10, establishes additional guidelines to prevent elected municipal officials from holding a prohibited financial interest in any contract to be paid for with municipal funds or with tax dollars; and

WHEREAS, Title 1, Chapter 7, Article A, Section 1-7A-8 of the Village's municipal code also sets guidelines intended to regulate the interest in contracts or transactions by Village officers, but that provision has created confusion about its appropriate application in a manner that potentially differs from the Illinois Compiled Statutes; and

WHEREAS, the Village Board has concluded that in order to ensure there are unambiguous guidelines for all public officials of the Village to follow, the Village Code should be amended to resolve this confusion.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS that

Section 1: The Municipal Code of the Village of West Dundee, Title 1: Administrative, Chapter 7: Village Officers and Employees, Article A: Code of Ethics, Subsection 1-7A-8: Interest in Contract or Transaction, shall be amended as follows:

1-7A-8: INTEREST IN CONTRACT OR TRANSACTION:

The Village hereby adopts and incorporates by reference all paragraphs, sections, and subsequent amendments of 50 ILCS 105/3 and 65 ILCS 5/3.1-55-10 in whole as Section 1-7A-8 of its Municipal Code.


Section 2: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

Section 3: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.


