

ORDINANCE 2021-05

An Ordinance Amending the Municipal Code of the Village of West Dundee, Illinois of 2004, as Amended, Providing a Provisional Amendment to Liquor License and Video Gaming License Applications and Fee Payments for the 2021-2022 License Year

WHEREAS, the Village of West Dundee, Kane County, Illinois is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Illinois Compiled Statutes Chapter 235 ILCS Article IV under the Illinois Liquor Control Act which has expressly conferred certain powers on municipalities with regard to the issuance of retail liquor licenses; and

WHEREAS, on March 16, 2020, Illinois Governor J.B. Pritzker signed the first of several Executive Orders related to the Coronavirus Disease 2019/COVID-19 pandemic, which mandated the suspension of on-premises service and consumption of food or beverages, and which directed Illinois residents to stay at home; and

WHEREAS, the COVID-19 public health crisis and attendant measures taken to protect the public health have created a significant economic challenge for businesses throughout the country and within West Dundee, which despite cautious and gradual reopening strategies, continue to this day; and

WHEREAS, in order to provide economic relief to food and beverage establishments within West Dundee, the Village will provide for an extension of the time for payment of fees for local liquor licenses and video gaming licenses for the May 1, 2021 through April 30, 2022 licensing year.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS:

Section 1: That a provisional amendment be made to the Municipal Code of the Village of West Dundee, Title 3, Chapter 2: Alcoholic Liquor Regulations, due to COVID-19 as follows:

- 1) One-time extension of time for payment of the annual Liquor License fees.
 - a) Payment of all Liquor License fees set forth in Section 3-2-9, typically due by May 1, shall be extended and shall be paid to the Village of West Dundee by October 31, 2021.

Section 2: That a provisional amendment be made to the Municipal Code of the Village of West Dundee, Title 3, Chapter 1, Section 9: License Fee Schedule, due to COVID-19 as follows:

- 1) One-time extension of time for payment of the annual Video Gaming License fees.
 - a) All Video Gaming License fees set forth in Section 3-1-9, typically due May 1, shall be extended and shall be paid to the Village of West Dundee by October 31, 2021.

Section 3: That renewal documentation for Liquor, Video Gaming and Tobacco Licenses are required to be submitted in their completed form by no later than April 12, 2021, with the exception of said payments, which will be due by no later than October 31, 2021.

In all other respects, Liquor and Video Gaming License policies remain unchanged and all Liquor and Video Gaming License holders are expected to continue to remain in compliance with state and local law and ordinances in terms of said licenses issued by the Village of West Dundee.


Section 5: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.


Section 6: That this Ordinance shall be in full force as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.
