

ORDINANCE 2018- 21

**ORDINANCE OF THE VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS
APPROVING AN AMENDMENT TO TITLE 10 OF THE WEST DUNDEE
MUNICIPAL CODE ADDRESSING PERMANENT MAKE-UP**

WHEREAS, the Village of West Dundee, Kane County, Illinois (the “*Village*”) is a home rule unit of local government pursuant to Article VII, Section 6(a) of the 1970 Constitution of the State of Illinois and as such has the power and authority to perform any function pertaining to its government and affairs and to promote the health, safety and welfare of its citizens; and,

WHEREAS, the President and Board of Trustees of the Village (the “Corporate Authorities”) have determined that permanent make-up as a use may be permitted within the Village’s Business Districts and as such would not have an adverse effect on property values of adjoining properties; and,

WHEREAS, the Corporate Authorities have resolved that rules and regulations should be adopted in order to ensure that permanent make-up as a use should not have an adverse effect upon the public health, welfare and safety of the residents of the Village and businesses operating within Village boundaries; and,

WHEREAS, the Village intends to amend its Zoning Code and its Municipal Code in order to define permanent make-up, list it as a use within its Business Districts, and require the business operation to be appropriately licensed.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of West Dundee, Kane County, Illinois, as follows:

SECTION 1. Title 10, Chapter 2, Section 10-2-1 of the Village Zoning Regulations is hereby amended to add the following definition:

“PERMANENT MAKE-UP: A cosmetic technique, often referred to as cosmetic tattooing, which employs tattoos applied semi-permanently or permanently to simulate the appearance of common cosmetic applications such as eyelines, lip lines, eyebrow enhancements and beauty marks or to otherwise semi-permanently or permanently restore or improve the appearance of damaged or disfigured skin and outer bodily features to natural coloration and condition.”

SECTION 2. Title 10, Chapter 5, ARTICLE B. B-1 DOWNTOWN BUSINESS DISTRICT, Section 10-5B-2 of the Village Zoning Regulations is hereby amended by adding the following under “**Permitted Uses**” in Business District:

“Permanent make-up services but only as ancillary or supplementary to a full-service hairstyling or beauty salon.”

SECTION 3. Title 10, Chapter 5, ARTICLE B. B-1 DOWNTOWN BUSINESS DISTRICT, Section 10-5B-3 of the Village Zoning Regulations is hereby amended by adding the following under “**Special Uses**” in Business District:

“Permanent make-up services as a standalone operation or the primary use within a hairstyling or beauty salon.”


SECTION 4. That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.
