# ORDINANCE 2012-15

# AN ORDINANCE AMENDING TITLE 7, CHAPTER 5 SEWER AND WATER DEPARTMENT OF THE MUNICIPAL CODE OF THE VILLAGE OF WEST DUNDEE, ILLINOIS OF 1994, AS AMENDED

WHEREAS, the Village Board has reviewed the Financial Statements of the Water and Wastewater Fund and recommendations of Village Staff and Auditors, and

WHEREAS, the Water and Wastewater Fund is an Enterprise Fund with the intent of providing utility service operations predominantly financed through user fees, and

WHEREAS, the corporate authorities of West Dundee have elected to implement revised water and wastewater rate structures in order to meet current existing operational needs as well as meet the anticipated future operational needs of these new utility facilities, and

WHEREAS, the Village Board will amend Title 7, Chapter 5 as follows, and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That Title 7, Chapter 5 Sewer and Water Department Section 7-5-9.2 Rates for Water and Sewer Services of the Municipal code of West Dundee, Illinois of 1994, as amended, be repealed in its entirety and replaced by the following Section 7-5-9.2 in lieu thereof:

#### 7-5-9.2: RATES FOR WATER AND SEWER SERVICE

A. There shall be and there are hereby established rates or charges for the use of and for water service supplied by the Village of West Dundee within the Village limits and for sewer service supplied by the village of West Dundee based on the amount of water billed, as shown on the water meters within or on each property.

**Section 2:** These rates shall be effective for all water/sewer bills issued on or after May 01, 2012.

<u>Section 3</u>: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

<u>Section 4</u>: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law and after publication in pamphlet form pursuant to the authority of the Board of trustees.
