

ORDINANCE 2014-21

**AN ORDINANCE AMENDING TITLE 3, CHAPTER 2,
ALCOHOLIC LIQUOR REGULATIONS OF THE MUNICIPAL CODE OF
THE VILLAGE OF WEST DUNDEE, ILLINOIS OF 2004, AS AMENDED**

WHEREAS, the Village of West Dundee, Kane County, Illinois is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Illinois Compiled Statutes Chapter 235 ILCS Article IV under the Illinois Liquor Control Act which has expressly conferred certain powers on municipalities with regard to the issuance of retail liquor licenses; and

WHEREAS, upon the approval of a Class A liquor license application submitted by Bootleggers Kitchen & Pub, located at 629 S. Eighth Street, and subject to the issuance of a certificate of occupancy for the same, an adjustment has been made to the number of allowed Class A licenses; and

WHEREAS, due to the closure of Fast & Easy at 1997 Huntley Road, an adjustment has been made to the number of Class C licenses.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS that

Section 1: The Municipal Code of the Village of West Dundee, Title 3 Chapter 2, Alcoholic Liquor Regulations, Section 3-2-9 Number of Licenses, as amended, shall be, and the same hereby is amended by repealing in its entirety the said Section 3-2-9 and enacting the following Section 3-2-9 in lieu thereof:

3-2-9: *NUMBER OF LICENSES: There shall be allowed one (1) Class AAA License, zero (0) Class AA License, nine (9) Class A Licenses, three (3) Class B Licenses, four (4) Class C Licenses, one (1) Class CC License, two (2) Class CCC Licenses, one (1) Class D License, five (5) Class E Licenses, one (1) Class F License, one (1) Class G License and zero (0) Class H Licenses.*

Section 3: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

Section 4: That this Ordinance shall be in full force and effect subject to and after the issuance of a certificate of occupancy for Bootleggers Kitchen & Pub at 629 S. Eighth Street, as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.


