**RESOLUTION 19-13**

**CERTIFICATE OF FULL REDUCTION OF TAXES HERETOFORE LEVIED FOR  
 THE PAYMENT OF GENERAL OBLIGATION BONDS, SERIES 2010A AND  
 2010B, OF THE VILLAGE OF WEST DUNDEE, ILLINOIS**

TO THE COUNTY CLERK OF KANE COUNTY, ILLINOIS

The undersigned, being the duly qualified and acting Village Treasurer of the Village of West Dundee, Illinois (the "Village"), having been directed and authorized by the Village Board of the Village of West Dundee to prepare and file this Certificate, do hereby certify and notify you as follows:

1. Pursuant to Ordinance No. 2010-23, adopted on December 7, 2010 providing for the issuance of \$4,000,000 General Obligation Bonds, Series 2010A/B, the Village was instructed to levy taxes in amounts sufficient to pay maturing principal of and interest on the General Obligation Bonds as set forth below:


2. You are hereby notified and directed to make the proper reduction of the taxes heretofore levied for the tax year 2019 for payment of the General


