

ORDINANCE 2012-21

An Ordinance Authorizing the Disposal of Surplus Office Furniture/Equipment from Public Safety Center #1

WHEREAS, 65 ILCS 5/11-76-4 (Chapter 65 of the Illinois Compiled Statutes) provides that when, in the opinion of a simple majority of the corporate authorities holding office, it is no longer necessary or useful to, or for the best interest of the Village to own certain personal property, then said corporate authorities may, by ordinance, authorize the donation of that personal property in such a manner they may designate, and:

WHEREAS, the Village of West Dundee, Kane County, Illinois, is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois and the pass of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS, THAT,

Section 1: Pursuant to 65 ILCS 5/11-76-4 of the Illinois Compiled Statutes, the President of the Board of Trustees find that the office furniture/equipment listed below owned by the Village of West Dundee is no longer useful to the Village and the best interest of the Village will be served by the disposal of said surplus property.

Section 3: This Ordinance shall be in full force and effect from and after its passage as provided by law.


