

ORDINANCE 2020-05

AN ORDINANCE AMENDING TITLE 6, CHAPTER 1, SECTION 18, VIDEO GAMING REGULATIONS, OF THE MUNICIPAL CODE OF THE VILLAGE OF WEST DUNDEE, ILLINOIS, ESTABLISHING A MAXIMUM NUMBER OF VIDEO GAMING TERMINALS PER LICENSED ESTABLISHMENT

WHEREAS, the Village of West Dundee, Kane County, Illinois is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, on February 4, 2013, the Village Board adopted Ordinance No. 2013-01, permitting Video Gaming within the community as provided by the Illinois Video Gaming Act, 230 ILCS 40, adopted effective July 13, 2009; and

WHEREAS, on June 28, 2019, the Governor Pritzker signed into law an expansion to the Illinois Video Gaming Act, which provided for an increase to the number of video gaming terminals per licensed establishment from five (5) to six (6) terminals; and

WHEREAS, the Village Board finds that it is in the best interests of the community's welfare, public health, and safety to amend the Village Code to impose a limitation of no more than five (5) video gaming terminals per licensed establishment, as originally authorized by the State of Illinois;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS that

Section 1: The Municipal Code of the Village of West Dundee, Title 6, Chapter 1, Section 6-1-18 Video Gaming, shall be, and is hereby, amended by the addition of Paragraph D, as follows:

- D. Number of Video Gaming Terminals: No Video Gaming License issued shall authorize the establishment or maintenance of more than five (5) video gaming terminals per licensed establishment, as originally authorized by the Illinois Video Gaming Act, 230 ILCS 40, adopted effective July 13, 2009.


Section 3: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.


Section 4: That this Ordinance shall be in full force as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.
