Certificate of Full Reduction of Taxes Heretofore Levied for the Payment of General Obligation Refunding Bonds, Series 2015, of the Village of West Dundee, Illinois

TO THE COUNTY CLERK OF KANE COUNTY, ILLINOIS

The undersigned, being the duly qualified and acting Village Treasurer of the Village of West Dundee, Illinois (the "Village"), having been directed and authorized by the Village Board of the Village of West Dundee to prepare and file this Certificate, do hereby certify and notify you as follows:

1. Pursuant to Ordinance No 2015-28, adopted on November 23, 2015 providing for the issuance of bonds not to exceed \$10,000,000 and the Bond Order that was filed with the Kane County Clerk's Office on December 23, 2015, the Village was instructed to levy taxes for tax levy year 2021 in the amount sufficient to pay maturing principal of and interest on the General Obligation Bonds as set forth below:
