

ORDINANCE 2012-05

**AN ORDINANCE AMENDING TITLE 3, CHAPTER 2,
ALCOHOLIC LIQUOR REGULATIONS
SECTION 3-2-9 NUMBER OF LICENSES OF THE MUNICIPAL CODE OF
THE VILLAGE OF WEST DUNDEE, ILLINOIS OF 2004, AS AMENDED**

WHEREAS, the Village of West Dundee, Kane County, Illinois is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Illinois Compiled Statutes Chapter 235 ILCS Article IV under the Illinois Liquor Control Act which has expressly conferred certain powers on municipalities with regard to the issuance of retail liquor licenses; and

WHEREAS, upon the review of an application by Bond Drug Company of Illinois, LLC (dba Walgreens) and the release of the license held by Clearwater Productions, adjustments have been made to the number of allowed Class AA, Class C and Class CCC licenses.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS that

Section 1: The Municipal Code of the Village of West Dundee, Title 3 Chapter 2, Alcoholic Liquor Regulations Section 3-2-9 Number of Licenses as amended, be, and the same hereby is amended by repealing in its entirety the said Title 3, Chapter 2, Section 3-2-9 and enacting the following Section 3-2-9 in lieu thereof:

3-2-9: *NUMBER OF LICENSES: There shall be allowed one (1) Class AAA License, zero (0) Class AA License, eight (8) Class A Licenses, three (3) Class B Licenses, four (4) Class C Licenses, one (1) Class CC License, two (2) Class CCC Licenses, one (1) Class D License, four (4) Class E Licenses, one (1) Class F License, one (1) Class G License and zero (0) Class H Licenses.*


Section 2: That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

Section 3: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law and after publication in pamphlet form pursuant to the authority of the Board of Trustees.
