## ORDINANCE 2013-02

## An Ordinance Amending Title 3, Chapter 2, Alcoholic Liquor Regulations Section 3-2-9, License Fees and Number, of the Municipal Code of the Village of West Dundee, Illinois of 2004, as Amended

WHEREAS, the Village of West Dundee, Kane County, Illinois is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Illinois Compiled Statutes Chapter 235 ILCS Article IV under the Illinois Liquor Control Act which has expressly conferred certain powers on municipalities with regard to the issuance of retail liquor licenses; and

WHEREAS, an adjustment has been made to the number of allowed Class A licenses based on the relinquishment of the license previously held by West End Restaurant and Bar; and

WHEREAS, upon recommendation by the Local Liquor Control, adjustments have been made to the fees associated with the Class A, Class B, Class C, Class CCC, Class D, Class F and Class G license categories.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS that

Section 1: The Municipal Code of the Village of West Dundee, Title 3 Chapter 2, Alcoholic Liquor Regulations Section 3-2-9 License Fees and Numbers as amended, be, and the same hereby is amended by repealing in its entirety the said Title 3, Chapter 2, Section 3-2-9 and enacting the following Section 3-2-9 in lieu thereof:
