

ORDINANCE 2010 -19

AN ORDINANCE CONCERNING THE CREATION OF A DEPARTMENT FOREIGN
FIRE INSURANCE BOARD

WHEREAS, the West Dundee Fire Department is a fire department duly organized pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of West Dundee President and Board of Trustees (the "Board") has authority to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the West Dundee Fire Department (65 ILCS 5/11-6-1); and

WHEREAS, the Act further provides that the municipality of each qualifying fire department shall set aside all money received by the municipality pursuant to §11-10-1 of the Illinois Municipal Code, 65 ILCS 5/11-10-1, and the Board shall appropriate said money to the Foreign Fire Insurance Board; and

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of West Dundee as follows:

Section One: The Board of Trustees finds the recitals above to be true and correct and incorporates them herein by reference.

Section Two: The Board of Trustees shall, upon the receipt of foreign fire insurance tax funds, set apart such funds for appropriation to the Fire Department's Foreign Fire Insurance Board.

Section Three: Upon its formation, the Foreign Fire Insurance Board of this Fire Department shall promulgate rules pursuant to §11-10-1 of the Illinois Municipal Code, and shall comply with all other applicable state and federal laws, including, but not limited to the State Officials and Employees Ethics Act (5 ILCS 430/1-1 *et seq.*), Open Meeting Act (5 ILCS 120/1

et seq.), the Local Records Act (50 ILCS 205/1 *et seq.*), and Freedom of Information Act (5 ILCS 140/1 *et seq.*), as amended from time-to-time.

Section Four: The Board of Trustees shall ensure that the funds appropriated to the Foreign Fire Insurance Board are included in Village's annual audit to ensure that said funds are spent for the "maintenance, use, and benefit" of the West Dundee Fire Department.

Section Five: All expenditures for equipment, supplies, or services purchased by the Foreign Fire Insurance Board shall be in accordance with all Village of West Dundee ordinances, policies, procedures, and rules concerning the expenditures of monies.

Section Six: This Ordinance shall be in full force and effect upon its passage and shall supersede any ordinances or resolutions, in conflict with any part herein, and any such ordinances or resolutions as hereby repealed to the extent of any such conflict.

Section Seven: If any section, paragraph, or provision of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Ordinance.


