ORDINANCE NO. 12-28

AN ORDINANCE ADOPTING THE TAX LEVY OF THE SPECIAL SERVICE AREA #3 WITHIN THE VILLAGE OF WEST DUNDEE, ILLINOIS.

WHEREAS, the Village of West Dundee, Kane County, Illinois, did on September 18, 2000 adopt Ordinance # 00-27 which created the Established of Special Service Area #3 within the Village of West Dundee; and

WHEREAS, the purpose of this Special Service Area is to provide special municipal services to certain properties within the Village in the form of the installation of electrical service upgrades as it relates to the undergrounding of utilities within this Special Service Area; and

WHEREAS, there is provided by the terms of said Ordinance, the imposition of an additional tax to repay the Village of West Dundee for this work performed; and

WHEREAS, the said services will be funded by the levy of an annual tax not to exceed the annual rate of .8 percent per annum of the assess value, as equalized, of the property in the Special Service Area #3 and

WHEREAS, for tax levy year 2012 the Village of West Dundee hereby levying the sum of:

THIRTY- FIVE THOUSAND DOLLARS (\$35,000.00)

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of West Dundee, Illinois as follows:

<u>Section One</u>: The Clerk of the Village of West Dundee, Kane County, Illinois is directed to file a certified copy of this Ordinance with the Clerk of Kane County, Illinois within the time provided by law.

Section Two: This Ordinance shall be known as Ordinance No. 12 -28 and shall be in full force and effect immediately upon its passage and approval as required by law.

<u>Section Three:</u> If any section, paragraph, subdivision, clause, sentence or provision of the Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgement shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.
