

**ORDINANCE 2021-12**

**AN ORDINANCE CHANGING THE NAME OF THE STREET KNOWN AS  
MCCONNOCHE COURT TO MCCONNOICHE COURT  
IN THE VILLAGE OF WEST DUNDEE**

WHEREAS, McConnoiche Court is one of many local residential streets in the Village;  
and

WHEREAS, the Hill Subdivision Unit No. 2 Plat as approved by the Village of West  
Dundee in April 1989 and recorded with Kane County in June 1989 identified this street as  
"McConnoche Court" which did not reflect an accurate spelling of this street name; and

WHEREAS, property addresses along McConnoiche Court are referred to as  
McConnoche Court in the Kane County Geographic Information System's (GIS) data set; and

WHEREAS, in order for the Village of West Dundee's internal Informational Technology  
(IT) system to synchronize with Kane County's GIS data set and function properly, the  
corporate authorities have determined that it is advisable to officially change the street's name to  
"McConnoiche Court".

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF  
TRUSTEES OF THE VILLAGE OF WEST DUNDEE, KANE COUNTY, AS FOLLOWS:

Section 1. The street legally-named "McConnoche Court" in the Hill Subdivision Unit No.  
2 Plat recorded as Document No. 1979385 on June 16, 1989 shall hereafter be designated,  
named, and known as "McConnoiche Court" as shown on Exhibit A attached hereto.

Section 2. The Village Clerk is hereby directed to forward, by certified or registered mail,  
a certified copy of this Ordinance to the local United States Post Office, and the Kane County  
Clerk/ Elections Department, without delay.

Section 3. Any and all ordinances, resolutions and orders, or parts thereof, in conflict with  
the provisions of this Ordinance are to the extent of such conflict superseded and waived.


Section 4. If any section, subdivision, sentence or phrase of this ordinance is for any  
reason held to be void, invalid or unconstitutional, such decision shall not affect the validity of  
the remaining portions of this Ordinance.


Section 5. This Ordinance shall be in full force and effect from and after its passage,  
approval and publication as provided by law, provided, in no event shall this Ordinance take  
effect sooner than thirty (30) days after the election authorities having jurisdiction in the area,  
and the post office branch serving the area, have been notified by the corporate authorities of  
the change of name described in this Ordinance, by certified or registered mail, in accord with  
the requirements of the Illinois Municipal Code, 65 ILCS 5/11-80-19.

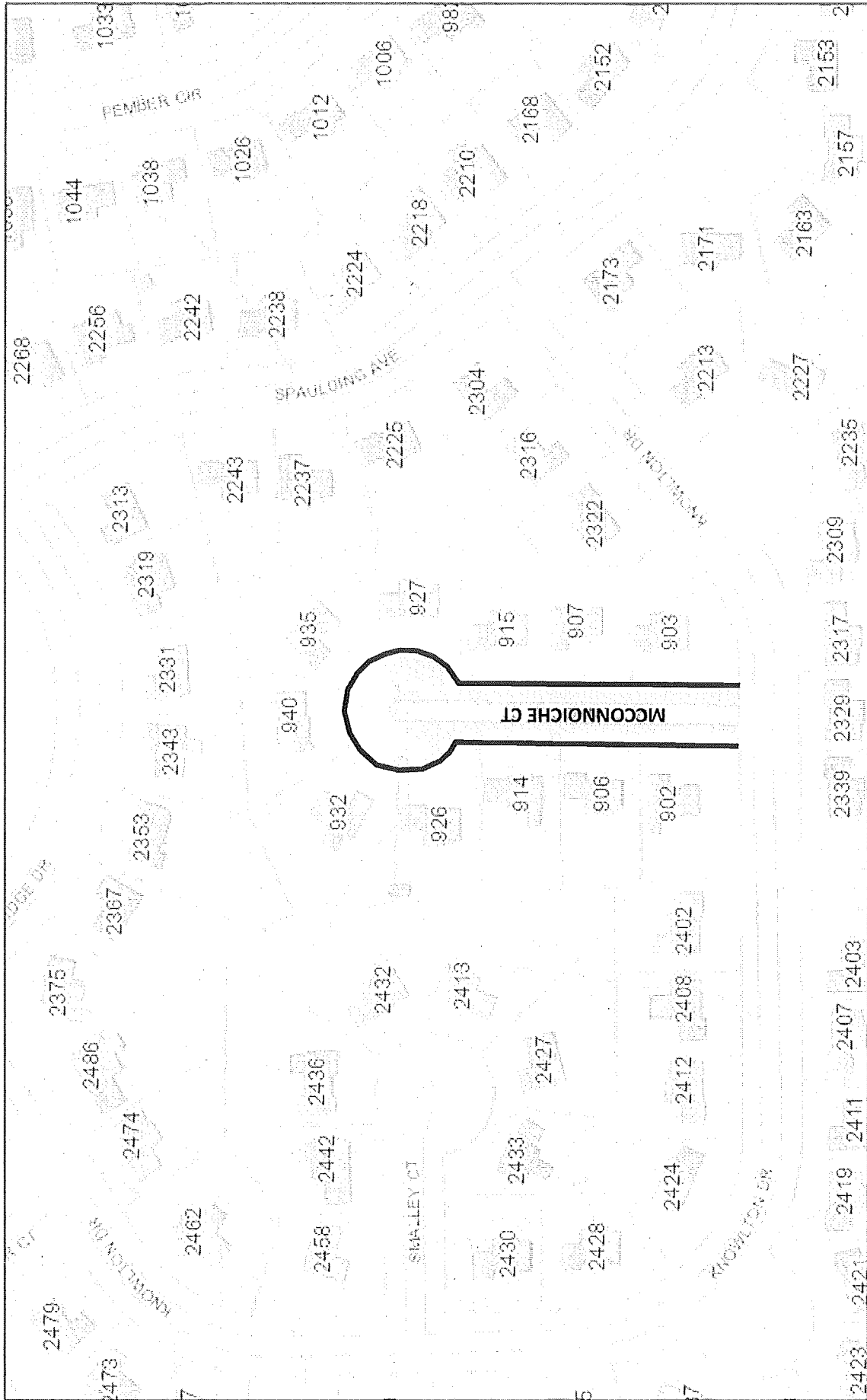
