

ORDINANCE 2022-27

**An Ordinance Declaring Surplus Equipment and Vehicles  
of the Village of West Dundee, Illinois**

WHEREAS, 65 ILCS, 5/11-76-4 (Chapter 65 of the Illinois Compiled Statutes) provides that when, in the opinion of a simple majority of the corporate authorities holding office, it is no longer necessary or useful to, or for the best interests of the Village to own certain personal property, then said corporate authorities may, by ordinance, authorize the disposition of that personal property in such a manner they may designate, and;

WHEREAS, the Village of West Dundee, Kane County, Illinois, is a home rule municipality as contemplated under Article VII, Section 6 of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES, VILLAGE OF WEST DUNDEE, KANE COUNTY, ILLINOIS, that:

Section 1: Pursuant to 65 ILCS 5/11-76-4 of the Illinois Compiled Statutes, the President and Board of Trustees find that the vehicles and equipment owned by the Village of West Dundee are no longer useful to the Village and the best interest of the Village will be served by the sale of said surplus property:


Section 3: This Ordinance shall be in full force and effect upon its passage and approval in the manner provided by law.
