VILLAGE OF WEST DUNDEE, ILLINOIS  
ANGLE TARN WTP REMODELING

1. Time and Place of Opening Bids. Sealed proposals for the construction of the Angle Tarn WTP Remodeling for the Village of West Dundee, Kane County, Illinois, will be received at the Village Public Works Department at 900 Angle Tarn, West Dundee, Illinois until 10:00 A.M DST, February 19, 2019, and at that time will be publicly opened and lump sum bid read aloud.

2. Description of Work. The proposed construction consists of six parts; 1) Replacement of the face-pipe, flow meters, and control valves on four existing softeners as well as Brine Pipe and pipe supports on Softener No. 1 (Base Bid), 2) Extending a 6-inch high service pump surge discharge line into the softener room to provide water for emergency softener backwashing and softener regeneration, 3) Replacing the steel underdrain in Softener No. 3 with a hybrid PVC header and lateral type encased in concrete grout including replacement of the support gravel and ion exchange resin, 4) Replacing the steel underdrain in Softener No. 4 with a hybrid PVC header and lateral type encased in concrete grout including replacement of the support gravel and ion exchange resin, 5) Removal of pump control valves on the three high service pumps with spools with tapping saddles for insertion type flow meters as well as removal of an expansion joint on the pump suction and installation of a silent check valve, 6) Installation of flow meters on the two wells entering the building, and other miscellaneous items of work.

Not less than the prevailing rate of wages as determined by the Department of Labor or determined by the court on review shall be paid to all laborers, workmen and mechanics performing work under this contract.

The Village of West Dundee, Illinois is exempt from the Illinois State, municipal or county Retailers Occupation Tax, Service Occupation Tax, Use Tax, and Service Use Tax as described in Illinois Compiled Statute Chapter 35. Bid prices shall not include the cost of such taxes.

All Bids must be accompanied by a Bidder's bond, certified check, bank cashier's check or bank draft payable to the Village of West Dundee, Illinois for ten percent (10%) of the total amount of the Bid as provided in the Bidder Instructions.

A **mandatory** Pre-Bid Conference of all prospective Bidders and/or their representatives will be held at the Public Works Department, 900 Angle Tarn, West Dundee, Illinois on February 5, 2019 at 10:00 AM DST. Bidders are **required** to attend and participate in the conference.
